The FVLCRUM's holding will modify and change from 36% to 48%. The company shall use this amount to repay long term loans and as a result, the quantum of long term loan in the consolidated financial statement of the Company will be reduced to that extent.

Commenting on the investment deal, Mr. N.C.V. Rangacharya, Managing Director stated that, as the Company is seeing tremendous growth in the business and expanding rapidly, the board feels with this dilution the company will converse cash for future company growth and helps to meet regular cash flow requirements. In addition, due to high inflation, the borrowing costs in USA have increased tremendously. The reduced interest burden will add to the bottom line.
